TRANSACTION LIMITS

SoFi Securities has set withdrawal and deposit transaction limits on your SoFi Money cash management account to protect your account against fraudulent activity. Transaction limits are set based on confidential fraud and risk criteria that are essential to your protection and may be modified at our sole discretion without advance notice. You can check your withdrawal and deposit limits at any time by accessing SoFi Chat on the SoFi App or SoFi.com or by calling us at 1-855-456-7634. Depending on our assessment of your account, these limits may be higher or change with time. Unless otherwise noted, limits are based upon Eastern Standard Time.

Debit Card Cash Withdrawals

Our debit card daily limits are maintained by our debit card processor which is based in the Mountain Standard Time. Limits are set for each debit card issued. ATM operators can enforce their own per transaction limit.

Deposit Limits

ACH Deposits (Initiated from SoFi app or website)

We may establish limits on the dollar amount and/or number of ACH deposits that you make to your account. If you attempt to initiate an ACH deposit in excess of these limits, we may reject it. Your dollar deposit limit will be disclosed to you at the time that you initiate a transfer on the SoFi Mobile app. SoFi reserves the right to change these limits at any time in our sole discretion.

Mobile Check Deposit

We may establish limits on the dollar amount and/or number of check images or mobile check deposits that you make to your account. If you attempt to initiate a mobile check deposit in excess of these limits, we may reject your mobile check deposit. If we permit you to make a mobile check deposit in excess of these limits, such mobile check deposit will still be subject to the terms of the SoFi Money Customer Agreement, and we will not be obligated to allow such a mobile check deposit at other times. Your dollar deposit limit will be disclosed to you at the time that you make the mobile check deposit on the Samsung Wallet app or the SoFi Mobile app. SoFi Securities reserves the right to change these limits at any time in our sole discretion.

Cash Deposit

SoFi Securities has set the following transaction limits for cash deposits at Green Dot retailers. Limits are set for each debit card issued. Individual retailers have the right to establish lower limits. Note that the limits are based on rolling time periods not on calendar days. For example, if a \$500 deposit is made at 11:00 AM MT and another \$500 deposit at 11:05 AM MT, the next cash deposit cannot be made until 11:01 AM MT the next calendar day. These limits are based on the Mountain Standard Time.
